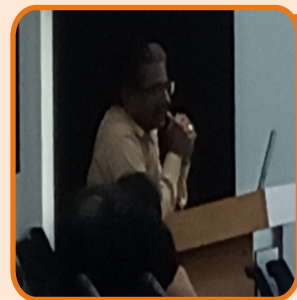

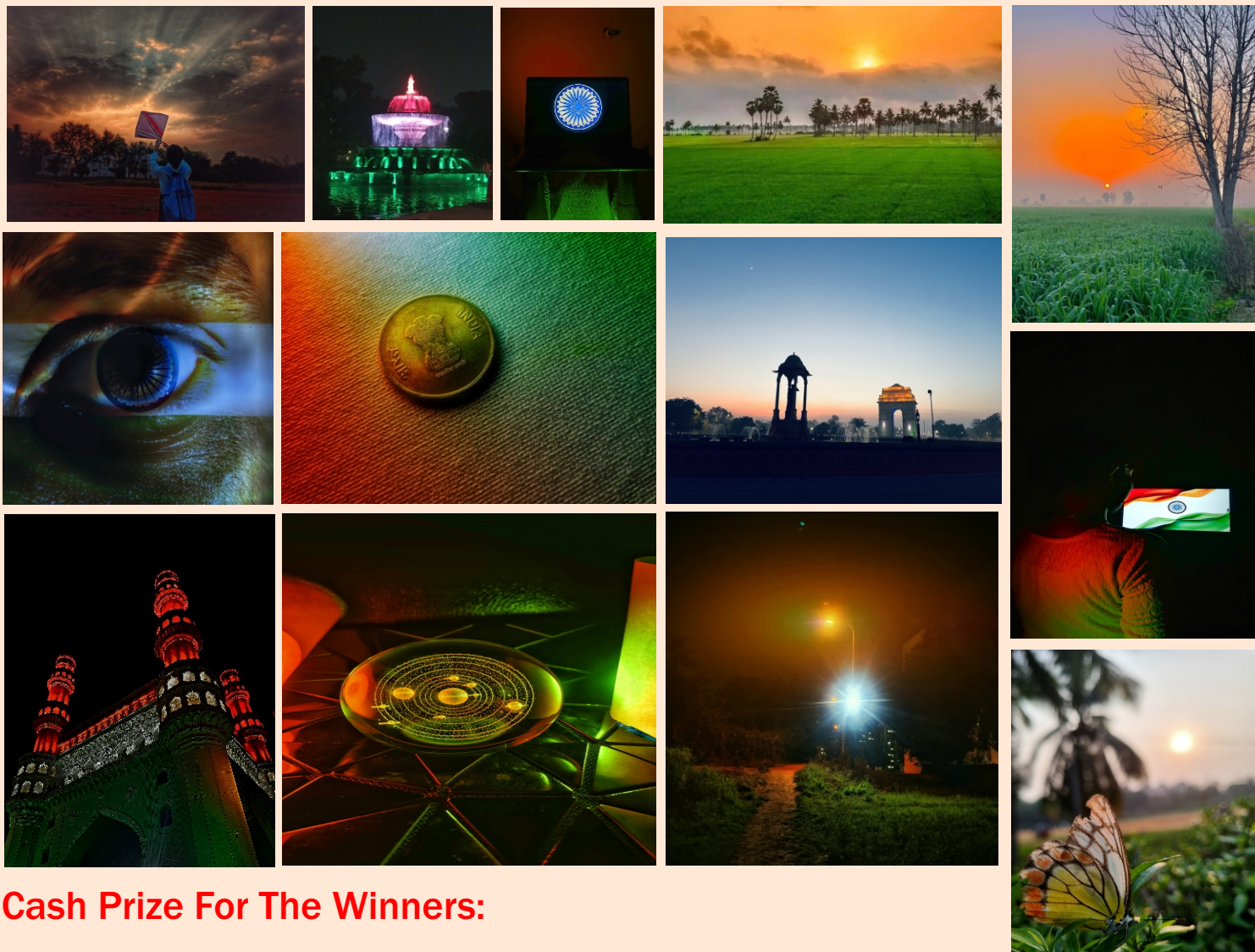
Legal Aid Club Activity

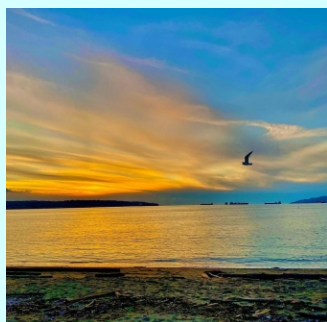

Guest Lecture



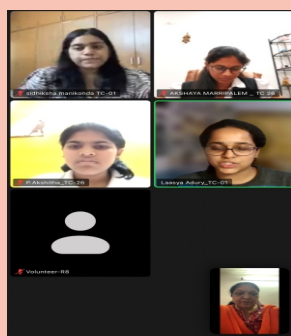

Literacy Program

ICFAI Law School, Hyderabad, Organized Literacy and Awareness Program for Housekeeping Staff. The foundation of an egalitarian society is access to education for all. Education empowers people, brings equality and prosperity in the society. With this ideology the ICFAI Law School, IFHE Hyderabad started a learning program for its housekeeping staff. The objective of the campaign was to enhance their level of education and awareness about various Socio-economic aspects. Out of 13 housekeeping members only 4 male members knew reading and writing and only two female members knew how to read. Approximately 80% of the staff in the age group of 30 to 40 years were illiterate. These adults couldn't read street signs (except red, yellow and green light), couldn't search phone number and didn't know the important contact numbers like police help line number, ambulance number etc. Few strategies like class room teaching, guest lectures, group discussions and educational videos were employed to achieve the goal of the campaign.
